## October 2, 2018

The Village Board of Trustees met in regular session at 7:00 p.m. on October 2, 2018 with Moore, LeFrois, Schukei, Meier and Young present. The Chairperson Pro Tempore, at the beginning of the meeting, informed the public about the location of the posted current copy of the Open Meetings Act.
