The Village Board of Trustees met in regular session at 7:00 p.m. on February 6, 2018 with Moore, Young, Rash, Schukei and Meier present. The Agenda items listed thereon were sufficiently descriptive to give the public reasonable notice of the matters to be considered at the meeting. The Chair, at the beginning of the meeting, informed the public about the location of the posted current copy of the Open Meetings Act. Chairperson Moore named the three (3) areas where the agenda was posted as follows: Community Building, Village Clerk's Office, and Eagle State Bank.

Open Forum – John Surman (450 Eagle Dr.) said the semi-truck parked at 340 Highway 34 is still parked in violation of the Village's sight triangle regulations. Nystrom said a letter was sent from the office after the last board meeting asking the property owner to remediate this concern. Surman said this condition still exists. Nystrom will follow up with the Village Attorney on this matter.
