BE IT FURTHER RESOLVED that the Clerk of the Village of Eagle Nebraska, shall publish notice of the proposed sale of the above described items of personal property, and the terms thereof, by the posting of a notice of said sale in three prominent places within the Village of Eagle, Nebraska, for a period of not less than seven (7) days prior to the sale of said items of personal property, after the passage of this Resolution. Purpose: The purpose of the Eagle Elementary 12th annual Fun Run is to raise funds for the PTE organization general fund. The money is used to purchase items needed by teachers and the school. The event will be hosted by the Eagle PTE and was approved by District 145.

Goals: To promote a healthy lifestyle and sense of community for the children and families of Eagle.

To celebrate the season, enjoy the outdoors and be active.

To provide a fun, healthy, family event held annually.

To raise money to benefit the students of Eagle Elementary.


Proposal: Proposed parking would consist of the school parking lot north and east of the school and parking around the softball complex. With the proposed route, we will try to avoid street parking. Proposed race distance is 1 mile. Proposed route would limit closure of streets to a minimum and allow cars through the intersection when it is not being used by runners. Our race will start and finish in the school's South parking lot. See attached map for suggested route.

Supplies Needed: Could we please get two-four cones located at each intersection along the one mile route and two street blocking barricades for each side of the school parking driveway? We will be responsible to put them out and stack them back up at the conclusion

1 mile kids run – Proposed start time would be approx. 530pm first run, last one at 645pm – Start at school's south parking lot, F to 6th, 6th to D, D to 1st and finish in the school's South parking lot. We will have staggered start times per grade every 15 min.

The PTE will provide a biker for the run to ensure all individuals follow the correct route and that all runners finish or exit the route appropriately. The biker will also follow the last runner/walker in the final race at 645pm. The PTE will also provide volunteers at each cross street to ensure cars stop and runners are able to cross safely. The PTE will use spray chalk to mark arrows on the streets to identify the route The PTE will also contact Eagle Volunteer Fire Department to request paramedics be available for the event. The registration form will include a waiver, releasing the PTE, District 145 and the Village of Eagle from any liability, and will require an adult's signature. All runners/walkers will be required to wear masks during the course of the event. No rain date has been selected, only cancel if there is lightning.

VILLAGE OF EAGLE

March 2, 2021

The Village Board of Trustees met in regular session at 7:00 p.m. on March 2, 2021 with Surman, Meier, Moore, Weyers and Caylor present. The Agenda items listed thereon were sufficiently descriptive to give the public reasonable notice of the matters to be considered at the meeting. The Chairperson, at the beginning of the meeting, informed the public about the location of the posted current copy of the Open Meetings Act. Chairperson Surman named the three (3) areas where the agenda was posted as follows: Eagle Municipal Building, Eagle Fire & Rescue Department and Eagle Municipal Park.

Report from Law Enforcement – Sergeant Sommer said there were 46 calls for service during the month of February with 2 summons and 7 warnings/violations issued. Surman said if a vehicle is tagged for not moving there should be follow up action taken by law enforcement. Sommer agreed. Surman said the report indicates a service call at Friendship Lane and asked where this is located. Sommer said he is unsure; unfortunately, this address must have popped up as an Eagle address in the Sheriff's Department's system which resulted in it displaying on the report. Meier reported a vehicle parked in front of the fire hydrant at 3rd & C Street, several vehicles that haven't moved for an extended period of time and a fire call at 509 S. 4th Street where dogs were being cremated in the rear yard. Moore asked if there is anything law enforcement can do to help with vehicles containing expired license plates parked on the street. Sommer said yes; typically law enforcement tries to make contact with the residents first ahead of issuing tickets; it is also helpful to provide a list of known violators to law enforcement.

Report from Building & Zoning Administrator – Hestermann reported 1 new building permit, 2 certificates of occupancy and 7 inspections during the month of February. There are 30 total open permits to date.

Open Forum – No public comment.

Discuss/possible action: 2021 swimming pool season and hiring of seasonal employees – Meier said he would like to see the swimming pool open this season but has learned that there are only a few applications that have been submitted thus far. Caylor said she would like to see a total of 20 applications by this Friday because lifeguard certification classes at the YMCA are already full through the end of April; if there is any hope in opening the pool everyone will need to be certified by mid-May. Moore asked if there are any other lifeguard certification trainers available. Brooklynn Kreikemeier (625 Douglas Cir.) said she personally knows both of the lifeguard certification trainers at the YMCA; if the Village Board is able to provide CPR dummies it is an option to have these trainers available in Eagle to certify all of the lifeguards at one time. Caylor asked if this would be the appropriate certification

through DHHS. Kreikemeier said yes. Aaron Newell (250 Wenzel Cir.) said lifeguard certification courses can also be taken at Genesis Health Clubs in Lincoln. Julie Kreikemeier (625 Douglas Cir.) said a bigger problem she sees is every year the swimming pool seems to be on the chopping block; whether it be for staffing, pool system functionality or cost of operation; this is the first time, however, that the Village Board has tried to decide whether or not the pool will open ahead of advertising for employment; she believes the general feeling of the public is not to apply for a job that may or may not even exist. Caylor said at this time the opening of the pool is still tentative. Weyers said she did make some phone calls today to communities in the surrounding area and nobody is planning on making any pool opening decisions until the first part of May. Julie Kreikemeier said there has been a community outcry to open the swimming pool; there have been 509 signatures obtained via an online petition to open the pool in the first 24 hours; the pool needs to be open before a determination can be made whether there is going to be adequate staffing available. Surman asked what would happen if the Village Board agreed to open the pool but there wasn't enough staff to operate it. Kreikemeier said there were times in the past where the pool was short staffed and had to be closed on certain days throughout the season, but ultimately the community was able to pull through; if the pool sits empty for a second consecutive season it is going to be a complete loss to the community and there will be a lot of upset residents; the public is telling the Village Board by the online petition and coming to the meeting tonight what their opinion is. Terri Todd (940 Applewood Dr.) said the longer a decision is delayed to open the pool the likelier the odds of failure; the Pool Manager needs adequate time to recruit lifeguards and pool staff for the season. Cynthia Franzen (605 S. 2nd St.) said her daughter has already applied for a position at the swimming pool even though there has been no current hiring advertisement in place; with the COVID-19 pandemic everyone is just assuming the pool is going to be closed again this year. Nystrom said Pool Manager and Assistant Pool Manager positions were posted for hiring per the Village Board's request at the February 2, 2021 meeting; lifeguard and pool office assistant positions have not yet been advertised. Shawna Schildt (325 Wenzel Cir.) said her daughter applied for a position last year before the pool was closed due to the COVID-19 pandemic; now she is just waiting to hear what decision is made regarding the pool before she applies again. Caylor said she does have concerns if Eagle ends up being the only pool opening in the vicinity and the issues that will arise such as crowd control and an increased risk of COVID infection in the community; the Village Board would have to then consider staggered swim times of 90 minutes, thorough disinfection by the pool staff for 30 minutes and no repeat business throughout the day. Moore provided documentation to the Village Board on recommendations by the CDC on how to operate a public swimming pool; it would be a matter of the Village Board setting stringent guidelines and pool management enforcing the rules and regulations. Marcus Hochstein (625 S. 4th St.) said instead of waiting on other communities to decide whether or not they will open their swimming pools the Village of Eagle should start the trend. Paco Rodriguez (620 S. 5th St.) said he supports opening the swimming pool but would prefer Eagle is not compared to the City of Lincoln when it comes to pool openings. Caylor said her biggest concern as a nurse and healthcare professional is the four new variants of COVID-19 that

have shown to attack children more than the initial variants; the PICU in Omaha is up 30% in admissions with COVID-related organ shutdown; this is why she initially pushed for inoculation this year and revisiting the pool being opened next year. Tracy Masek (840 S. 3rd St.) said indoor sports are being played without masks so she doesn't see that big of problem outside at a swimming pool where chlorine and other chemicals exist in the water. Danielle Smulling (19120 Adams St.) said children are not required to wear masks at school during outside recess and it should be up to the parents whether they feel comfortable sending their kids to the swimming pool. Julie Kreikemeier said it is wonderful that the Village Board is concerned about the wellbeing of the children in the community but it would be impossible for anyone to pin the blame on the swimming pool if someone is exposed or comes down with COVID. Weyers said the Village Board was elected to be stewards of the community and asked if the public will be upset if a substantial amount of money is spent on opening the pool only to be forced to close it down part way through the season. The general consensus from the public in attendance at the meeting was yes. Weyers said opening the pool this year is a risk so she wanted to make sure the public understood that.

Motion by Meier, second by Moore, to tentatively open the swimming pool for the 2021 season and to advertise for the hiring of seasonal swimming pool employees. Voting: Ayes – 5. Motion carried.

Discuss/possible action: Approve Eagle Vision's request for an annual Easter Egg Hunt event on March 27, 2021 and consider the donation of pool passes – Tracy Masek said Eagle Vision is looking for a donation of four individual pool passes contingent upon the swimming pool opening this season. The Easter Egg Hunt will proceed as normal this year with proper social distancing and mask mandates in place. Surman asked if a backup date has been established in the event of inclement weather. Masek said yes, April 3, 2021.

Motion by Meier, second by Weyers, to approve Eagle Vision's request for an annual Easter Egg Hunt on March 27, 2021 and the donation of four individual pool passes contingent upon the swimming pool opening for the 2021 season. Voting: Ayes – 5. Motion carried.

Discuss/possible action: Approve the following requests by Eagle Vision for Eagle Days on June 26, 2021:

- A. Street closings, barricades and parade route Tracy Masek provided the Village Board with a map indicating the proposed parade route and desired locations for street closings and barricades. The route map provided by Eagle Vision is the same as year's past.
- B. Waiver of vendor fees Surman said typically a fee is collected from each vendor when items are privately sold in the Municipality. Each of the last several years, Eagle Vision has made a request to the Village Board to waive

AN ORDINANCE OF THE VILLAGE OF EAGLE, CASS COUNTY, NEBRASKA, TO AMEND CHAPTER 1, ARTICLE 5, SECTION 1-510, OF THE MUNICIPAL CODE OF THE VILLAGE OF EAGLE, NEBRASKA AS THE SAME RELATES TO THE ORDER OF BUSINESS FOR MEETINGS OF THE VILLAGE OF EAGLE BOARD OF TRUSTEES; TO REPEAL ALL ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE FOR THE SEVERABILITY OF ANY SECTION, CLAUSE, PROVISION OR PORTION FOUND UNCONSTITUTIONAL OR INVALID; TO PROVIDE THAT THIS ORDINANCE SHALL BE PUBLISHED AND SHALL BE IN FULL FORCE AND TAKE EFFECT FROM AND AFTER ITS PASSAGE AND APPROVAL, AS PROVIDED BY LAW AND AS PROVIDED HEREIN; AND TO PROVIDE THAT THE PROVISIONS OF THIS ORDINANCE SHALL BECOME AND BE MADE A PART OF THE MUNICIPAL CODE OF THE VILLAGE OF EAGLE, NEBRASKA, AND THE SECTIONS OF THIS ORDINANCE MAY BE RENUMBERED TO ACCOMPLISH SUCH INTENTION.

WHEREAS, the Village of Eagle Board of Trustees shall, by ordinance, establish an order of business for conducting its business.

NOW, THEREFORE, BE IT ORDAINED BY THE CHAIRMAN AND BOARD OF TRUSTEES OF THE VILLAGE OF EAGLE, NEBRASKA, as follows:

Section 1. Chapter 1, Article 5, Section 1-510 of the Village of Eagle, is amended as indicated:

§1-510 MEETINGS; ORDER OF BUSINESS

All meetings of the Governing Body shall be open to the public. Promptly at the hour set by law on the day of each regular meeting, the members of the Governing Body, the Municipal Clerk, the Chairperson, and such other Municipal officials that may be required shall take their regular stations in the meeting place, and the business of the Municipality shall be taken up for consideration, and disposition in the manner prescribed by the official agenda on file at the office of the Municipal Clerk. Each meeting of the Governing Body shall begin with the recitation of the Pledge of Allegiance.

Section 2. That the Chair and the appropriate Department, whether one or more, of the Village of Eagle, Nebraska, are hereby authorized and directed to implement this Ordinance.

Section 3. That all Ordinances and parts of Ordinances passed and approved prior to the passage, approval, and publication of this Ordinance, in conflict herewith, are hereby repealed.

Section 4. That should any section, paragraph, sentence of this Ordinance hereby adopted be declared for any reason invalid, it is the intent of the Chair and Governing Body of the Village of Eagle, Nebraska, that it would have passed all other portions of this Ordinance independent of the elimination here from of any such portion as may be declared invalid.

Section 5. That this Ordinance shall be published within the first 15 days after its passage and approval either in pamphlet form or by posting in three public places in the Village of Eagle, Nebraska, and shall be in full force and take effect on the 15th day from and after its passage, approval, and publication, as provided herein.

Section 6. That it is the intention of the Chair and Governing Body of the Village of Eagle, Nebraska, and it is hereby ordained that the provisions of this Ordinance shall amend the Municipal Code of the Village of Eagle, Nebraska, and the sections of this Ordinance may be renumbered to accomplish such intention.

Discussion: Moore said he and Weyers discussed the idea of reciting the Pledge of

Allegiance at the beginning of each board meeting and felt it was a good idea to get the feelings of the rest of the Village Board. Surman asked who the appropriate department is that is authorized and directed to implement this Ordinance per Section 2 of Ordinance 2021-04. Freeman-Caddy said the department in this particular case is the Village Board Chairperson. Surman said he personally does not feel the recitation of the Pledge of Allegiance needed to be made a part of the Municipal Code. Moore said his rationale is the Ordinance will place the recital of the Pledge of Allegiance in the official order of business regardless of who the Chairperson may be in the future.

Motion by Moore, second by Meier, to accept the first reading of Ordinance 2021-04. Voting: Ayes – 5. Motion carried.

Motion by Moore, second by Meier, to suspend the rules of three consecutive readings of Ordinance 2021-04. Voting: Ayes – 5. Motion carried.

Motion by Moore, second by Weyers, to adopt Ordinance 2021-04. Voting: Ayes -5. Motion carried.

Discuss/possible action: Consider options for the sale of the 2004 Road Rescue Ambulance - Hank Oetjen (Fire Chief) said he recently learned that the State of Nebraska has a new law that if an ambulance doesn't meet NFPA Standards it cannot be sold to another agency as an ambulance; the unit can still be sold privately as a regular vehicle after the lights and sirens are removed. Freeman-Caddy said she believes that is accurate. Oetjen asked if there is direction from the Village Board as to how they would like to proceed with selling the ambulance. Aaron Hofeling (Fire Lieutenant) said although this is a Nebraska law, other states in the vicinity do not necessarily have these same rules, which means the ambulance could potentially be sold to another state. Terry Caddy recommended placing the ambulance for sale online at Auction Time, Purple Wave and Big Iron; the cost will be roughly 8% to sale the ambulance and is likely to bring in more money than selling it locally. Freeman-Caddy said legally the only way to sell personal property outside a public offering is to sell it to another public entity; a Resolution to sell personal property in an amount presumably greater than \$5,000 is recommended. Freeman-Caddy was directed to draft a Resolution for the sale of the 2004 Road Rescue ambulance ahead of the March 15, 2021 board meeting. No further action taken.

Discuss/possible action: Consider options for the purchase and installation of a metal awning at the Eagle Fire & Rescue station – Two bids were received for the project; Bid 1 with JLC Exteriors in the amount of \$3,823.00 and Bid 2 with Heartland Awning & Design in the amount of \$6,480.00. Meier said the bids are for one awning but he thought both awnings were being considered. Caylor said the classroom awning is actually constructed into the building itself which would be a bigger undertaking than the one entering the station. Oetjen said the awning entering the station is leaking terribly and results in issues opening the door when it freezes. Caylor asked if the bid from JLC Exteriors includes demolition of the existing awning and any repairs that

may need to be done after its removal. Josh Crook (JLC Exteriors) said yes. Meier inquired about a project time frame. Crook said he estimates the job will be completed within 3 months. Moore said this project was not specifically included in the budget. Nystrom said miscellaneous station upgrades were included in the budget in the amount of \$4,000 and recommended this project be allocated under that specific area of funding.

Motion by Weyers, second by Caylor, to approve JLC Exteriors proposal to purchase and install a metal awning at the Eagle Fire & Rescue station in the amount of \$3,823.00. Voting: Ayes – 5. Motion carried.

Motion by Meier, second by Caylor, to approve the purchase of Weed and Feed from Frontier Cooperative-Walton in an amount not to exceed \$2,000. Voting: Ayes – 5. Motion carried.

Motion by Moore, second by Caylor, to approve an Electronic Recycling Event with Keep Cass County Beautiful on June 12, 2021. Voting: Ayes – 5. Motion carried.

Discuss/possible action: Approve 2021 Village of Eagle brush chipping rules – Nystrom provided the Village Board with a preliminary letter to residents indicating the brush chipping rules for 2021. Moore asked if there was anything the maintenance staff has encountered that should be added to the list of rules for brush chipping services. Terry Caddy said the most frustrating aspect is the small piles of 3"-4" limbs thrown on the ground that requires extensive bending over to pick up. The Village Board agreed to add a rule indicating that small twigs and branches be placed in containers or wheel barrows for ease of loading.

Motion by Moore, second by Caylor, to approve the 2021 Village of Eagle brush chipping rules as amended. Voting: Ayes – 5. Motion carried.

Motion by Meier, second by Surman, to approve minutes as typed for the previous meeting. Voting: Ayes -5. Motion carried.

Motion by Weyers, second by Meier, to approve claims as presented. Voting: Ayes – 5. Motion carried.

Report from Attorney – Freeman-Caddy said she printed the Municipal Code insert updates and will provide them to Nystrom. The payment was received from Roland Meyer for the purchase of the former office/shop property located at 540 C Street; once processed, Meyer will have 60 days to complete demolition. Moore said the property at 509 S. 4th Street is becoming a nuisance in more than one way and there have been questions and concerns about its use as a residential property in a commercially zoned area. Freeman-Caddy said with the variety of concerns present there are also a variety of enforcement procedures to be followed; for instance, the animal concerns require law enforcement intervention and the alleged residential use concerns require intervention by the Building & Zoning Administrator once witnesses are willing to testify to the same.

Report from Clerk/Treasurer – Nystrom said Polly Frye's first day was March 1, 2021 and training for her position as Deputy Clerk Treasurer is underway. The office has identified a number of unlicensed and/or inoperable vehicles and letters have been sent to those property owners in violation of Municipal Code. Nystrom will be reaching out to the Eagle Way mobile home community regarding the trailer that caught fire last December and still needs to be removed. The total income ending February 28, 2021 was \$85,500.22.

Motion by Moore, second by Caylor, to go into executive session at 8:51 p.m. to discuss hiring for the full-time Maintenance position and to protect the reputation of applicants. Voting: Ayes – 5. Motion carried.

Chairperson Surman said the board has come out of executive session at 9:14 p.m. after discussing hiring for the full-time Maintenance position. Nystrom will be directed to conduct a background check and schedule an interview with the applicant selected for employment consideration.

The meeting was adjourned at 9:15 p.m.
