## VILLAGE OF EAGLE

## July 15, 2019

The Village Board of Trustees met in regular session at 7:00 p.m. on July 15, 2019 with Moore, Meier, Surman and Lahmon present. Schukei was absent. The Agenda items listed thereon were sufficiently descriptive to give the public reasonable notice of the matters to be considered at the meeting. The Chairperson, at the beginning of the meeting, informed the public about the location of the posted current copy of the Open Meetings Act. Chairperson Moore named the three (3) areas where the agenda was posted as follows: Eagle Municipal Building, Eagle Fire & Rescue Department and Eagle State Bank.

Open Forum – Lori Rohlfs (500 S. 6<sup>th</sup> St.) said she received a letter from the Village office indicating the parking lot at the park is only open until 10:00 p.m. and unattended cars left in the park after hours will be towed. Rohlfs explained that she has a single driveway and it was suggested by Village staff that she park on the east side of 6<sup>th</sup> Street. Rohlfs began having her daughter park parallel to 'D' Street in the grassy area southeast of the swimming pool. On the morning of July 9, 2019, Rohlfs said she received a "threatening and bullying" phone call from Moore asking her to remove the car from the grassy area by 9:00 a.m. or the vehicle will be towed; a request that she felt was unreasonable. Rohlfs asked if an ordinance is in place disallowing vehicles to park parallel along 'D' Street in this area. Moore said the vehicle was not parked along 'D' Street but rather up in the grassy area which is municipal property and part of the park. Rohlfs asked if Moore is currently just driving by the area or "stalking" her. Moore said he is a member of the Park Board and visits the park and pool on a regular basis and has taken notice of this particular situation.

## **ORDINANCE NO. 2019-08**

AN ORDINANCE OF THE VILLAGE OF EAGLE, CASS COUNTY, NEBRASKA, TO AMEND CHAPTER 5, ARTICLE 6, SECTION 5-605, OF THE MUNICIPAL CODE OF THE VILLAGE OF EAGLE, NEBRASKA AS THE SAME RELATES TO PARKING OF TRUCKS, TRAILERS AND RECREATIONAL VEHICLES ON MUNICIPAL STREETS; TO REPEAL ALL ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE FOR THE SEVERABILITY OF ANY SECTION, CLAUSE, PROVISION OR PORTION FOUND UNCONSTITUTIONAL OR INVALID; TO PROVIDE THAT THIS ORDINANCE SHALL BE PUBLISHED AND SHALL BE IN FULL FORCE AND TAKE EFFECT FROM AND AFTER ITS PASSAGE AND APPROVAL, AS PROVIDED BY LAW AND AS PROVIDED HEREIN; AND TO PROVIDE THAT THE PROVISIONS OF THIS ORDINANCE SHALL BECOME AND BE MADE A PART OF THE MUNICIPAL CODE OF THE VILLAGE OF EAGLE, NEBRASKA, AND THE SECTIONS OF THIS ORDINANCE MAY BE RENUMBERED TO ACCOMPLISH SUCH INTENTION.

## **ORDINANCE 2019-09**

AN ORDINANCE TO ESTABLISH A SALARY RANGE FOR MUNICIPAL EMPLOYEES; TO PROVIDE FOR THE EFFECTIVE DATE HEREOF; TO REPEAL ALL ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE THAT THIS ORDINANCE SHALL BE PUBLISHED WITHIN THE FIRST 15 DAYS AFTER ITS PASSAGE AND APPROVAL EITHER IN PAMPHLET FORM OR BY POSTING IN THREE PUBLIC PLACES IN THE VILLAGE OF EAGLE, NEBRASKA, AND SHALL BE IN FULL FORCE AND TAKE EFFECT FROM AND AFTER ITS PASSAGE, APPROVAL, AND PUBLICATION, AS PROVIDED HEREIN; AND TO PROVIDE THAT THIS ORDINANCE SHALL NOT BECOME AND BE MADE A PART OF THE MUNICIPAL CODE OF THE VILLAGE OF EAGLE, NEBRASKA, AND THE SECTIONS OF THIS ORDINANCE MAY BE RENUMBERED TO ACCOMPLISH SUCH INTENTION.

Motion by Lahmon, second by Surman, to approve a \$500.00 donation to Nebraska Rural Water Association for their assistance in location and installation of a stop box at 600 South 2<sup>nd</sup> Street. Voting: Ayes – 4. Motion carried.

Motion by Lahmon, second by Meier, to approve minutes as typed for the previous meeting. Voting: Ayes – 4. Motion carried.

Motion by Moore, second by Lahmon, to approve the removal of Julie Kreikemeier, Erin Krumland, Krystal Rash and Liz Gillaspie from the Eagle Park and Recreation Commission. Voting: Ayes – 4. Motion carried.

Motion by Moore, second by Lahmon, to appoint Kayla Johanson, Elizabeth Umshler and Cassidi Denton to the Eagle Park and Recreation Commission. Voting: Ayes – Meier, Lahmon, Moore. Nays – Surman. Motion carried.

The meeting was adjourned at 8:32 p.m.
