

# July 5, 2022

The Village Board of Trustees met in regular session at 7:00 p.m. on July 5, 2022 with Surman, Caylor and Todd present. Meier and Weyers were absent. The Agenda items listed thereon were sufficiently descriptive to give the public reasonable notice of the matters to be considered at the meeting. The Chairperson, at the beginning of the meeting, informed the public about the location of the posted current copy of the Open Meetings Act. Chairperson Surman named the three (3) areas where the agenda was posted as follows: Eagle Municipal Building, Eagle Fire & Rescue Department and Eagle Municipal Park. The Pledge of Allegiance was recited.

Open Forum – Surman reminded the Village Board that items budgeted during this fiscal year do not automatically carry over to the next budget cycle. Surman said one of the portable toilets being used during Eagle Days was upset down at the park and asked if renting seven units was necessary or if it provided an invitation for individuals to cause damage. Marcus Hochstein (625 S. 4<sup>th</sup> St.) said there was definitely a need for the seven portable toilets and he does not believe the number of units played a role in the one being upset at the park.

Motion by Caylor, second by Todd, to approve Change Order No. 2 with Cather & Sons Construction for the Parkview Avenue / Wenzel Circle Mill & Overlay Improvements Project in the amount of \$13,862.93. Voting: Ayes – 3. Motion carried.

  - D. The Village Clerk and Village Board Chair shall have authority to facilitate this transaction and the Village Board Chair sign any documents required to engage the services of the online auction service and to transfer ownership documents upon final sale.

# July 5, 2022

The Village Board of Trustees met in regular session at 7:00 p.m. on July 5, 2022 with Surman, Caylor and Todd present. Meier and Weyers were absent. The Agenda items listed thereon were sufficiently descriptive to give the public reasonable notice of the matters to be considered at the meeting. The Chairperson, at the beginning of the meeting, informed the public about the location of the posted current copy of the Open Meetings Act. Chairperson Surman named the three (3) areas where the agenda was posted as follows: Eagle Municipal Building, Eagle Fire & Rescue Department and Eagle Municipal Park. The Pledge of Allegiance was recited.

Report from Law Enforcement – Law Enforcement not present. No report was received.

Report from Building & Zoning Administrator – Hestermann reported 1 new building permit, 4 certificates of occupancy and 5 inspections during the month of June. There are 18 total open permits to date. Todd asked how long building permits remain open. Hestermann said typically six months; however, as long as construction work is active, the permit will remain open. Freeman-Caddy said if work stops for a period of six months the permit will expire.

Open Forum – Surman reminded the Village Board that items budgeted during this fiscal year do not automatically carry over to the next budget cycle. Surman said one of the portable toilets being used during Eagle Days was upset down at the park and asked if renting seven units was necessary or if it provided an invitation for individuals to cause damage. Marcus Hochstein (625 S. 4<sup>th</sup> St.) said there was definitely a need for the seven portable toilets and he does not believe the number of units played a role in the one being upset at the park.

Discuss/possible action: Approve Change Order No. 2 with Cather & Sons Construction for the Parkview Avenue / Wenzel Circle Mill & Overlay Improvements Project in the amount of \$13,862.93 – Surman said the purpose of the change order is to include additional full depth asphalt patching on 4<sup>th</sup> Street; after discussing the situation with a member of the Street Committee (Meier) and the Village Engineer, it was determined to be in the best interest of the village to have the work completed while the equipment was already onsite. Surman said a total of \$100,000 was budgeted for the project and the total cost of the project after this change order will be \$97,324.18. Todd asked if the entire project has been completed. Surman said yes.

Motion by Caylor, second by Todd, to approve Change Order No. 2 with Cather & Sons Construction for the Parkview Avenue / Wenzel Circle Mill & Overlay Improvements Project in the amount of \$13,862.93. Voting: Ayes – 3. Motion carried.

Discussion: Review of Fiscal Year 2021 Audit as presented by Gabriel, Burger & Else, CPA, PC – The Village Board received a digital copy of the Fiscal Year 2021 Village of Eagle Basic Financial Statements and accompanying Independent Auditor's Report for review ahead of tonight's meeting. Surman said one deficiency that was noted again this year is the village's inability to adequately segregate duties to decrease the risk of possible errors or irregularities. This deficiency has been present on the audit report for many years and the village continues to look into ways to implement compensating controls to reduce the risk of lack of segregation of duties. Surman said another deficiency that was noted was regarding uncleared transactions; the recommendation is the village does not carry any uncleared deposits for longer than 7 days and all unclaimed property be submitted to the State of Nebraska. Nystrom said the other two deficiency findings detailed financial statement preparation and significant adjustments; the office will work with the audit team to make corrections in these two areas going forward. Todd said she works in accounting and would be more than willing to assist the office staff as needed.

Report from Attorney – Freeman-Caddy said she is working on final updates to the zoning ordinance revisions based on workshop discussions with the steering committee. She has begun setting aside time strictly for Eagle on Thursdays in order to get this process completed. Freeman-Caddy said she received an inquiry from an attorney regarding the administrative process for the Eagle's Landing subdivision west of town. Surman said there is an ordinance against parking trailers on the street for a period of time exceeding 12 hours; he recently witnessed a trailer on the street from Sunday to Friday and asked if there is any liability to the village if an accident occurs. Freeman-Caddy said she wouldn't necessarily be concerned with a liability scenario unless it is parked further out into the driving area; ultimately, the best idea would be to educate the resident(s) about the law, and if they still do not obey, their property could be towed. Caylor recommended this specific parking regulation be placed in the memo section of the next utility bills for public education purposes.

Report from Clerk/Treasurer - Nystrom said the Nebraska Auditor of Public Accounts has received the Fiscal Year 2021 Audit; the highway allocation funds that were withheld prior to receipt of the audit have now been received by the village. Nystrom said effective July 1, 2022 there was an increase of \$0.28/gallon for sodium hypochlorite (bleach) and \$0.03/pound for hydrochloric acid for the swimming pool due to tight supply and high demand across the nation. The Budget Workshop will be scheduled in mid to late August with Lisa Riley (Mierau & Co.); any capital outlay items or budget recommendations need to be received by the office by no later than July 25, 2022. Nystrom discussed recent issues with dogs and cats running at large, unlicensed and dangerous; the office has reached out to Lincoln Animal Control to see if they can be of assistance or offer recommendations to abate these issues. The new security surveillance system is up and running. Nystrom said the transfer switch on the South Meadows lift station generator is not functioning properly and will be inspected tomorrow morning by Nebraska Generator. Todd said the park hours are until 10:00 p.m. but there are vehicles that sit in the parking lot overnight. Nystrom said in the past he has tagged vehicles that park overnight warning them of the park hours so he will look into doing this again. The total monthly income ending June 30. 2022 was \$147,166.86.

The meeting was adjourned at 7:47 p.m.
