ORDINANCE NO. 2021-10

AN ORDINANCE OF THE VILLAGE OF EAGLE, NEBRASKA TO AMEND CHAPTER 9. ARTICLE 7. SECTION 9-705 OF THE EAGLE MUNICIPAL CODE AS THE SAME RELATES TO THE MOVING OF MOBILE HOMES; TO PROVIDE FOR THE SEVERABILITY OF ANY SECTION. CLAUSE, **PROVISION** OR PORTION **FOUND** UNCONSTITUTIONAL OR INVALID; TO REPEAL ALL ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE THAT THIS ORDINANCE SHALL BE PUBLISHED WITHIN THE FIRST 15 DAYS AFTER ITS PASSAGE AND APPROVAL EITHER IN PAMPHLET FORM OR BY POSTING IN THREE PUBLIC PLACES IN THE VILLAGE OF EAGLE, NEBRASKA, AND SHALL BE IN FULL FORCE AND TAKE EFFECT FROM AND AFTER ITS PASSAGE, APPROVAL, AND PUBLICATION, AS PROVIDED HEREIN; AND TO PROVIDE THAT THIS ORDINANCE SHALL BECOME AND BE MADE A PART OF THE MUNICIPAL CODE OF THE VILLAGE OF EAGLE, NEBRASKA, AND THE SECTIONS OF THIS ORDINANCE MAY BE RENUMBERED TO ACCOMPLISH SUCH INTENTION.

WHEREAS, the Village of Eagle has the authority to regulate all zoning and building regulations throughout its zoning jurisdiction, both within and without the corporate limits of the municipality and the Board of Trustees deem it to be in the best interest of said Village to modify the regulations pertaining to the moving of mobile homes with regard to enforcement of the same throughout the corporate limits.

NOW, THEREFORE, BE IT ORDAINED BY THE CHAIR AND BOARD OF TRUSTEES OF THE VILLAGE OF EAGLE, NEBRASKA, AS FOLLOWS:

Section 1. That the findings herein above made should be and are hereby made a part of this Ordinance as fully as if set out in length herein.

Section 2. Amend Municipal Code Section 9-705 as follows:

§9-705 BUILDING PERMITS; MOVING MOBILE HOMES.

Before any mobile home is moved within the Municipality, a permit allowing such movement shall be obtained. The fee for such permit shall be the sum of fifty dollars (\$50.00) one hundred dollars (\$100.00). Said permit shall be obtained from the Building Official. Upon approval, all mobile homes must be properly placed on assigned lot within sixty (60) days receipt of permit. Proper placement shall include mobile home being tied down according to manufacturer recommendations, placement on a hard surfaced pad, having appropriate skirting, and having appropriate hook ups to utilities. If mobile home placement occurs

prior to obtaining a permit, the Municipality shall charge and collect double the amount of the permit fee.

Section 3. That all other code sections, ordinances or parts of laws in conflict herewith are hereby repealed.

Section 4. That the Chair and the appropriate Department, whether one or more, of the Village of Eagle, Nebraska, are hereby authorized and directed to implement this Ordinance.

Section 5. That all Ordinances and parts of Ordinances passed and approved prior to the passage, approval, and publication of this Ordinance, in conflict herewith, are hereby repealed.

Section 6. That should any section, paragraph, sentence of this Ordinance hereby adopted be declared for any reason be invalid, it is the intent of the Chair and Governing Body of the Village of Eagle, Nebraska, that it would have passed all other portions of this Ordinance independent of the elimination here from of any such portion as may be declared invalid.

Section 7. That this Ordinance shall be published within the first 15 days after its passage and approval either in pamphlet form or by posting in three public places in the Village of Eagle, Nebraska, and shall be in full force and take effect on the 15th day from and after its passage, approval, and publication, as provided herein.

Section 8. That it is the intention of the Chair and Governing Body of the Village of Eagle, Nebraska, and it is hereby ordained that the provisions of this Ordinance shall amend the Municipal Code of the Village of Eagle, Nebraska, and the sections of this Ordinance may be renumbered to accomplish such intention.

RESOLUTION NO. 2021-05

WHEREAS, the Governing Body of the Village of Eagle, Nebraska, has enacted a Municipal Code, and,

WHEREAS, the Village Board of Trustees of the Village of Eagle, Nebraska, as the Village of Eagle's Governing Body, does desire to install speed limit signs in order to correct and prevent unsafe traffic conditions at the following locations which are located within the corporate limits of the Village of Eagle, Nebraska, to wit:

- A. A twenty-five (25) mile per hour speed limit sign on the south side of Olivia Drive at approximately 1215 Olivia Drive; and,
- B. A twenty-five (25) mile per hour speed limit sign on the north side of Olivia Drive at approximately 1208 Olivia Drive; and,
- C. A twenty-five (25) mile per hour speed limit sign on the south side of Gage Street at approximately 1315 Gage Street; and
- D. A twenty-five (25) mile per hour speed limit sign on the north side of Gage Street at approximately 1104 Gage Street.

NOW, THEREFORE, BE IT RESOLVED, by the Village Board of Trustees of the Village of Eagle, Nebraska, as follows:

- Section 1. That the findings hereinabove made should be and are hereby made a part of this Resolution as fully as if set out at length herein.
- Section 2. That traffic control devices, to wit: "25 mph" speed limit signs, be erected on the south side of Olivia Drive, north side of Olivia Drive, south side of Gage Street and north side of Gage Street.
- Section 3. Speed limit signs shall be erected and maintained according to all applicable rules and regulations enacted by the State of Nebraska; Cass County, Nebraska; and the Village of Eagle, Nebraska.

Section 4. That upon the approval of this Resolution, the aforenoted traffic control devices shall be erected and this Resolution shall remain in full force and effect until further action by the Governing Body.

WHEREAS, the Board of Trustees of the Village of Eagle, Nebraska, have held a public hearing upon said subdivision regulations, and.

WHEREAS, said subdivision regulations are in conformance with applicable statutes of the State of Nebraska and with the aforenoted Comprehensive Development Plan, and,

WHEREAS, it is the desire of the Board of Trustees of the Village of Eagle, Nebraska, to amend Section 301, Article 3, Chapter 11 of the Municipal Code of the Village of Eagle, Nebraska, by this Ordinance,

NOW, THEREFORE, BE IT ORDAINED BY THE CHAIRMAN AND BOARD OF TRUSTEES OF THE VILLAGE OF EAGLE, NEBRASKA, as follows:

Section 1. That the findings here and above should be, and they are hereby made a part of this Ordinance, as fully as if set out at length herein.

Section 2. That the Board of Trustees of the Village of Eagle, Nebraska, do hereby adopt Subdivision Regulations, dated _______, 2021 of the Village of Eagle, Nebraska, together with all explanatory material and supporting documentation, are hereby incorporated by reference and declared to be a part of this Ordinance. The Municipal Code of the Village of Eagle, Nebraska shall be amended by the, by amending §11-301 of the Municipal Code, to read as follows:

§11-301 SUBDIVISION REGULATIONS.

Discuss/possible action: Consider options for water leak repairs at 750 Applewood Drive – Josh Lahmon (245 S 4th St.) was present along with the property owner of 750 Applewood Drive, T'Jae Estes. Lahmon said there is water running into the property owner's basement at the service line, and to the best of his knowledge, the curb stop is going to be located underneath the tree in the front yard, which makes it inaccessible to shut off. Lahmon said the water line is likely made of PVC or poly

which makes it impossible to trace. Surman said one option would be to excavate the right-of-way and add a new service line and curb stop. Lahmon agreed and said the existing water line would also need to be shut off at the tap on the water main. Surman said it is always possible the curb stop will be found during excavation if it is not really underneath the tree. Lahmon said although unlikely, if that is the case it will be easy to identify which side of the curb stop is leaking. Surman asked what solution is being sought by the property owner and Village Board. Lahmon said he has concerns if the water line is made of PVC because it is an improper material and runs a greater risk of leaking again. Surman said the Eagle Water Service Manual states that PVC material is acceptable for water lines. Lahmon said PVC pipe or poly are required to have tracer wire installed for locating purposes and this is not the case at this property. Surman said the Eagle Water Service Manual was adopted after the house was built. Lahmon said once new construction or remodels are performed it must meet code. Surman asked if there is any input from the maintenance department. Curtis Klabenes said he feels everyone knows what work needs to be done it just needs to be determined who's responsible for what financially. Meier said he would feel comfortable splitting the cost with the property owner if the exact location of the leak cannot be determined. Surman said the first thing that will need to be done is to begin excavation to determine whether or not a curb stop is present; if a curb stop is not present he would tend to agree with Meier and consider splitting the cost with the property owner. Klabenes was directed to contact an excavator (Lovell Excavating or MI Diggers) and schedule the work to be performed at 750 Applewood Drive as soon as possible. The Water Committee was directed to conduct the remaining transaction as part of the project once the scope of work is determined by excavation. Estes was agreeable to the proposed terms and conditions. No further action taken.

Discuss/possible action: Update on ADA accessibility at the Eagle Municipal Office -Surman said there is a 1" lip as you enter the doorway of the main entrance at the Municipal Office and he is again asking for options to correct this. Wevers said the original ramp that she had in mind is not ADA approved; you would also need to have an automatic door opener. Surman said there is already an automatic door opener at the office; the only thing missing is an ADA approach. Weyers said if there is already an automatic door opener then a contractor certified in ADA work should be contacted next for approach options. Surman asked if the Building & Grounds Committee prefers to install a ramp or replace the existing concrete. Moore provided the Village Board with two options from Handi-Ramp for threshold ramps: the ramps are adjustable, made of welded aluminum with a grooved slip resistant surface and have a weight capacity of 800 pounds. Moore said these ramps are ADA approved for accessibility. Surman said his only concern at this point is the weight capacity limit due to the size of some of the wheelchairs. Meier said he is concerned with how long the ramp will last and feels it is a temporary solution. Weyers agreed and said new concrete would alleviate the concerns of durability and weight capacity. Moore said concrete may be a permanent solution but due to settling in front of the doorway he would recommend getting a ramp in the interim. Weyers asked if the maintenance department can install the ramp. Moore said yes.

Motion by Meier, second by Moore, to authorize the Buildings & Grounds Committee to purchase an ADA accessible threshold ramp for the Eagle Municipal Office in an amount not to exceed \$500.00.

Discuss/possible action: Update on public water supply system and future expansion - Surman said the Village Board was provided with a document tonight estimating the cost to install water mains in the conceptual development at Eagle Aerie south of Highway 34 and to increase the water main size along 4th Street and G Street (between Wulf Drive & the terminus of G Street). Surman said the existing water main size on both 4th Street and this section of G Street is only 4". Moore said if there is serious consideration to upgrade the water main size along G Street then sidewalks would need to be redone in this area simultaneously. Surman agreed and said the water main is currently underneath the existing sidewalks on the north side of G Street. Moore said he also feels a more comprehensive study for water and sanitary sewer should be conducted that looks at the current facilities, capacities and needs for future growth. Surman said a Water Model was conducted by Olsson a couple of years ago that may already provide some of these answers. Moore said he feels like the study conducted by Olsson was more focused on the potential development south of Highway 34 (Eagle Aerie). Surman, Klabenes and Nystrom agreed to review the Eagle Water Model Memo created by Olsson and review what additional information may be necessary in a future study. No action taken.

Motion by Weyers, second by Caylor, to approve the purchase of concrete for street repairs at 6^{th} & E Street in an amount not to exceed \$1,500.00. Voting: Ayes - 5. Motion carried.

Report on Streets and Maintenance - Klabenes said the roof coating of the Eagle Municipal Building began today. Hein Construction is projected to be in the area next month to begin crack sealing and routing the streets. Klabenes asked if there is any input on areas of emphasis for crack sealing. Surman said he would strongly urge the areas of new asphalt are crack sealed on F Street and Applewood Drive so water doesn't freeze underneath and cause damage. Klabenes asked if the edges of F Street and Applewood Drive should be crack sealed between the new surface and the edge of the curb. Meier said his opinion is yes. Meier said the Street Committee would also like something done for repairs on Wenzel Circle, an area of 2nd Street and an area of G Street. Nystrom said if these extensive projects are being considered they would have to go out for bid via the Village Engineer. Terry Caddy said maintenance has been street sweeping and trimming the creek in the park as time allows. Surman said he has noticed it has become difficult to navigate 4th Street with two lanes of traffic due to the size of some of the trucks parking in the business district. Weyers asked if there is a way to fix the issue. Surman said at one time there was parallel parking on both sides of 4th Street. Wevers said the issue is on a Friday or Saturday night there will be vehicles parked all over the residential streets if parallel parking is the only option. Surman said the tree along 6th Street east of the volleyball court is mostly dead and asked when it should be removed. The Park Committee will look into this concern and report back to the Village Board. Surman said the new property owner at 725 South 6th Street was required to install a sidewalk but currently there is no Village sidewalk abutting it that leads to F Street. Meier said he feels it would be a good idea to install the remainder of sidewalk to F Street. Moore urged the Village Board to keep in mind what may be done in this green space in the future before a sidewalk is installed.

Report on Wells and Sewer - Klabenes and Caddy attended the state inspection of the WWTP facility last week. Surman said one important note from the inspection is when the Chairperson changes on the Village Board you have 30 days to let the NDEE know or you will be in violation. Caddy said GPS locations are being obtained on curb stops so that they can be recorded on the Village's GWorks page. Nystrom said the issue is the GPS coordinates on a cell phone are not very accurate. Caddy said a different type of GPS unit will be needed to get the location accurate within a couple of feet. Moore said if bids are sought on a new GPS unit it can be placed on a future agenda for consideration. Klabenes said Johnson Service finished jet and vacuum work of this year's sanitary sewer mains. Surman said currently the Village is under the demand limit of 175,000 gallons per day for three consecutive days for water which means the Water Watch has been allowed to expire. Surman discussed the need for an additional well and asked if there is an opinion from the Village Board as to where it should be located. Weyers asked if there is already a generator present at the existing well house. Klabenes said yes. Caddy said the big question is whether the water we have is sufficient to run three wells. Surman said supposedly the water source is adequate for a third well. Caddy recommended a hydrological survey to determine how much water can be pumped from the existing source. Weyers asked if a different location would make sense for an additional set of wells. Surman said he is unsure; it was difficult to find this existing location at the time the current wells were drilled. Weyers said she would tend to prefer a second well field for security purposes. Nystrom said he will look for maps of aquifers in the area and report back at a future date. Surman mentioned that splash pads have been shut down in both Adams and Bennet due to water shortages.

Motion by Meier, second by Weyers, to approve minutes as typed for the previous meeting. Voting: Ayes – Caylor, Weyers, Meier, Surman. Moore abstained. Motion carried.

Report from Committees and Boards – Surman asked if the Human Resources Committee had an update on the potential new Full-time Maintenance Employee. Moore said an offer was made to the employee but his start date has potentially been set back to late July/early August; his suggestion is to wait the additional time period the applicant is requesting. Caylor said she tends to disagree due to the fact the wastewater system will soon be placed on the shoulders of the existing maintenance staff; if this potential employee falls through for whatever reason it will delay staffing that much longer. Weyers asked if the potential employee is licensed in water or sewer. Surman said no. Weyers recommended leaving the notice of hiring posted until a final decision is made by the potential employee. Moore said the issue with

continuing to advertise is the potential employee may see this as we are no longer interested in his services; additionally, there have been very little applications for the position over the course of the last few months. The general consensus of the Village Board was to follow up with the applicant based on the conditional offer of employment that was made by Moore as a member of the Human Resources Committee. Nystrom said he was contacted by the Eagle Farmer's Market about relocating their stands to the south side of the Eagle Municipal Building parking lot for the next two weeks due to firework sales at their regular location. The Village Board agreed to allow the Farmer's Market to operate in the Eagle Municipal Building parking lot on June 24th and July 1st to accommodate firework sales. Surman said the special meeting originally scheduled for tomorrow night has been cancelled. Moore asked if a conclusion was reached about the members of Eagle Fire & Rescue using the Hotsy to wash personal vehicles. Surman said it was determined that using the Hotsy on personal vehicles is not allowed but he is unsure if the information was adequately passed along to the members. Caylor said she will make sure the information is passed along at the next Fire & Rescue meeting. Surman said the Budget Workshop will be held in August and encouraged the Village Board to begin planning.

The meeting was adjourned at 8:34 p.m.
